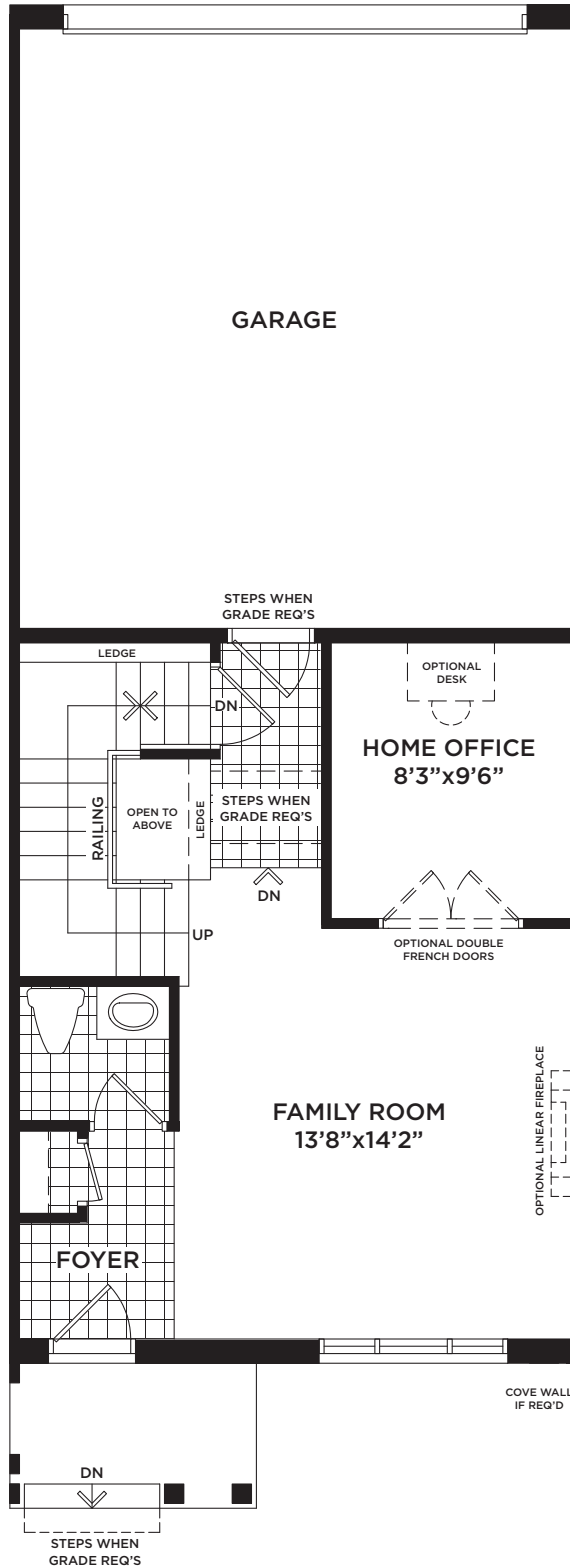

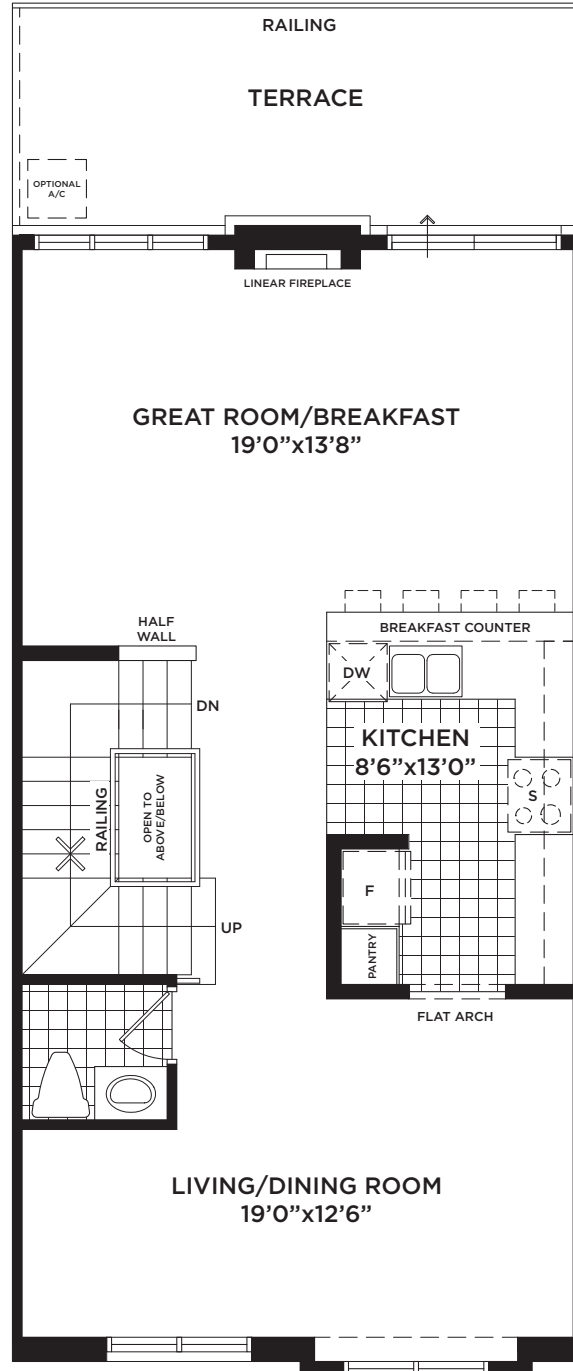

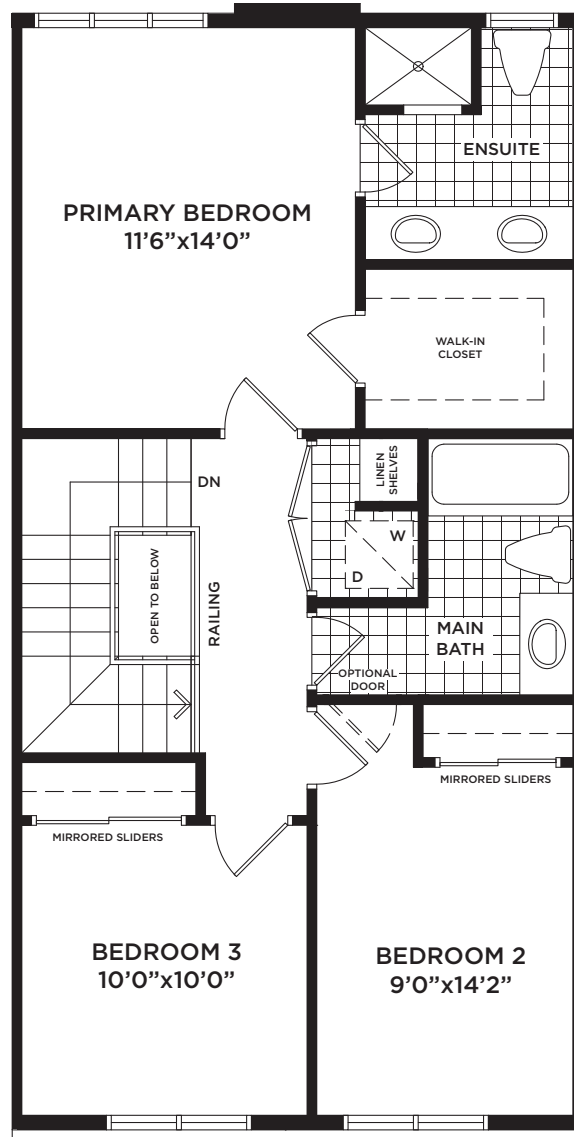

ELEVATIONS 'A' & 'B'



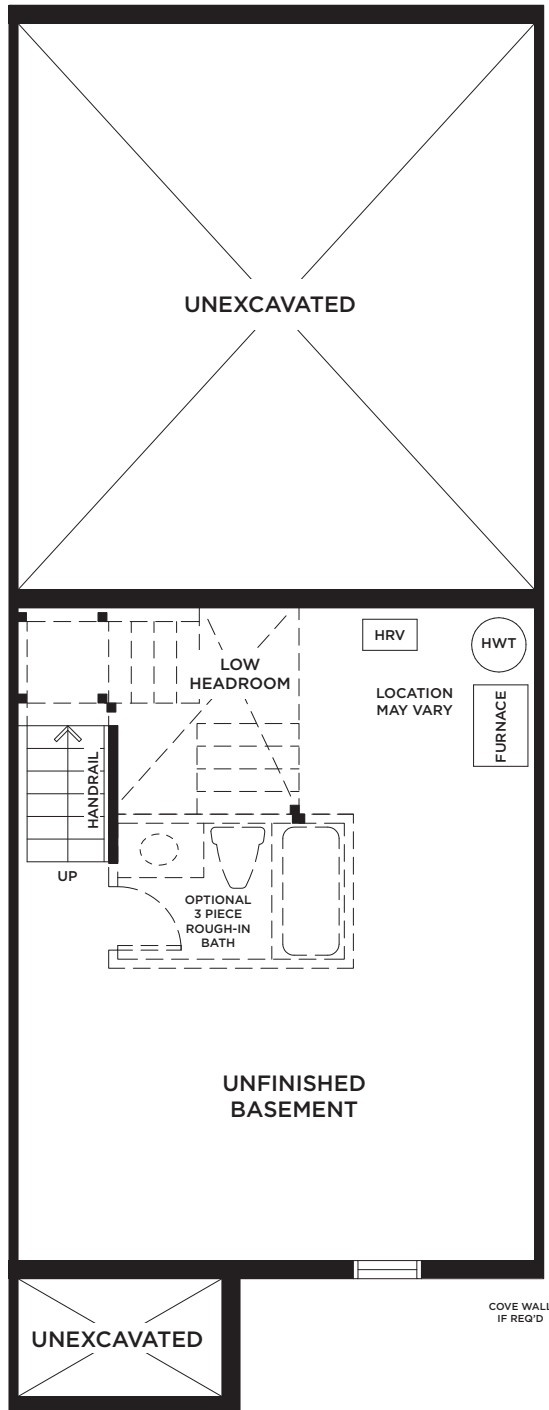

ELEVATIONS 'A' & 'B'



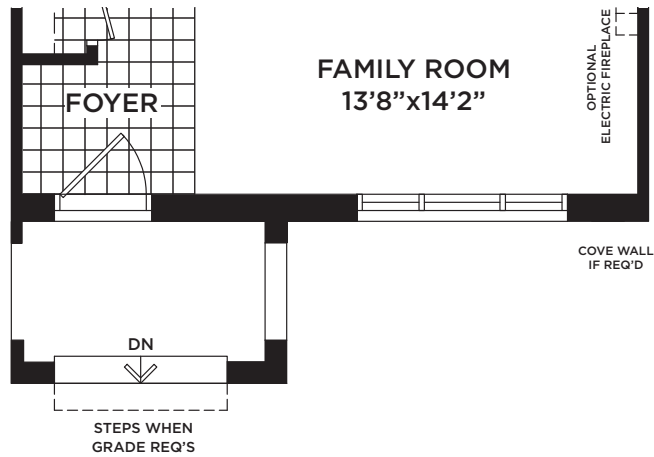

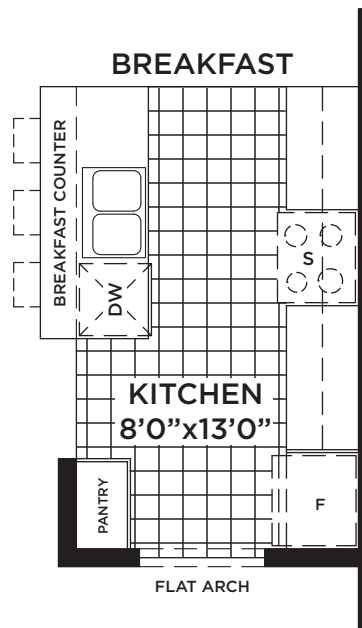
